# **Roommate Requests**

## **Housing Assignments**

First-Year students are assigned randomly to either Newton or Upper Campus. Approximately 900 students live on Newton and approximately 1,450 students live on Upper Campus. New Transfer students will be primarily assigned to the College Road Residence Halls.

The majority of rooms are double occupancy. There are a limited number of single, triple, and quad occupancy rooms on both campuses. Students may indicate up to 3 room type preferences in their housing application. For the 2025-2026 academic year, lofted triples will be utilized in rooms on upper campus to accommodate the first year class.

Each room is furnished with a bed, twin XL mattress (36" x 80"), desk, chair, and dresser for each student. Each room also contains a built-in closet, connections for cable TV, telephone, and internet. Most rooms have wall-to-wall carpeting.

## **Housing Guarantees**

The Office of Undergraduate Admission awards first-year students 3 or 4 academic years of university housing and transfer students are typically provided with 2 academic years of guaranteed on-campus housing. Students must meet all required deadlines each year to secure their housing.

Students admitted with 3 years of housing are guaranteed university housing for their Freshman, Sophomore, and Senior years. All guaranteed years start based on the enrollment date in the admissions letter; years of housing are non-transferrable.

Rising sophomores have the opportunity to take advantage of the <u>Sophomore Living Experience</u>, created to encourage new connections amongst the sophomore class.

## **Residence Hall Staff**

## **Resident Directors (RDs)**

Master's level professional live-in staff who supervise a specific residence hall/area, supervise the student staff, oversee operational and programmatic activities, act as a resource, and address community standards concerns.

#### Resident Assistants (RAs)

Full-time graduate and undergraduate students live-in staff who provide support, act as a resource for students, coordinate social and educational programs, and work together as a staff to enforce University policy.

#### Graduate Assistants (GAs)

Full-time graduate students who provide formational opportunities for residents by overseeing large scale programs, training activities, weekly conversation groups, and administrative components within the halls.

### Resident Ministers (RMs)

Full-time live-in professionals who serve as conversation partners and a pastoral presence for students while also offering hospitality and spiritual opportunities.
