## UPPER-LEVEL WRITING REQUIREMENT BOSTON COLLEGE LAW SCHOOL

Office of Academic & Student Services

All Boston College Law School students are required to take an upper-level course with a significant writing experience in order to graduate. It can be taken at any time during the second or third year.

- Students who intend to use a course to satisfy the upper-level writing requirement may not take the course Pass/Fail, if that is offered as an option.
- All 2 credit Independent Studies will satisfy the ABA writing requirement if writing a graded paper of 30 pages or more.

NOTE: One course can count towards satisfying the Perspectives requirement and *either* the upper-level writing or experiential learning/ lawyering skills requirement. One course *cannot* count towards both upper-level writing and experiential learning/lawyering skills.
