## THE H. MICHAEL MANN FUND

Mike Mann died on March 1 after having been ill and in a coma for just over a year. We mourn his passing but give thanks for his life and all that he did for us. Mike was a superb teacher, almost certainly our best known scholar, a practitioner as well as a scholar, a respected chairman and friend, and the editor of a journal which showed marked improvement under his direction. In the late sixties and throughout the seventies, he directed more dissertations than anyone else here. Mike had been selected for listing in Who's Who in Economics just before he was stricken a year ago.

The department has established the H. Michael Mann Fund at Boston College as a concrete way in which to recognize what Mike did for us and to show our appreciation. Proceeds of the fund will be used to provide summer dissertation grants to Ph.D. stu-Karen McCormick (Ph.D. 1982) and Patricia Lasonde (Ph.D. 1984) broached the idea some months ago, after talking to a number of other students, and James Meehan (Ph.D. 1967), James Dalton (Ph.D. 1969), and Teresa Amott (Ph.D. 1979) independently expressed their support. The fund is now operative, and with no real solicitation we have already raised \$1,700. We invite your support.
